Christina Deliyanni-Dimitrakou is a graduate of the Law School of the Aristotle University of Thessaloniki. Following her postgraduate studies in International Private Law and International Social Law at the Faculty of Law of the University of Geneva (Switzerland), she obtained her PhD diploma from the same university. She is an Associate Professor at the Law School of the Aristotle University of Thessaloniki, where she teaches Comparative Law and European Social Law at undergraduate and postgraduate levels as well as in the framework of the faculty's Erasmus Programme.

She has been a visiting professor at the Faculty of Law of the University of Dijon and Toulouse (France), while she is a member of the International Academy of Comparative Law, of the French Society of Comparative Legislation, the Greek Society of Labor Law and Social Security, the Thessaloniki Bar Association and of other scientific bodies. Additionally, in May 2017 she became vice president of the Coordinating Council of the Academic Network for the European Social Charter and the Social Rights ANESC / RACSE, which operates in the framework of the Council of Europe. Since 2011 she has also been one of directors of the Franco-Hellenic Master, which operates at the Law Schools of the Universities of Thessaloniki and Toulouse 1Capitol. In July 2017, the European Commission awarded her the chair Jean Monnet on «EU Social Rights Protection and Comparative Legal Cultures» following a competitive process that evaluated applications originated from more than 800 Universities around the world. In May 2018 she was also appointed Director of the Center for International and European Economic Law (CIEEL).

As a scientific co-coordinator and a member of various research groups, she has conducted several research programs funded by the European Union [see among others: European Commission Program 1997-1999 "Ligne Budgétaire N3-4000 Industrial Relations and social dialog 2000" (co-coordinator), EPEAEK Program Pythagoras I on "Cultural identities and cultural conflicts in the area of family law relationships and the gender perspective: Comparative approach" (co-coordinator), EPEAEK II, MIS:89206 - Pythagoras - 2.2 General on "Cultural identities and cultural conflicts in the area of family law relationships and the gender perspective: Comparative approach".
